**Position Summary:** Assists in preparing the produce, dairy and dessert items for guest that contributes to an overall excellent food service experience.

**General Purpose:** To help produce balanced guest meals by preparing cold food items (salad bar, dairy, desserts) so that it can help them connect with God & each other.

**Role Qualifications:**

- A personal relationship with Jesus Christ
- Must contain an excitement for the mission at Sandy Cove Ministries

**Essential Job Functions/Responsibilities:**

- Prepare salad bar, cheese trays, fruit trays, desserts and dairy condiments by chopping Fruits & vegetables, making and cutting desserts and placing fruits, vegetables and cheeses on appropriate trays
- Place prepared salad bar items in appropriate place, monitor & maintain level of food items during meals
- Meet guest requests, including special dietary needs
- Assist in maintaining the highest level of cleanliness and safety within Kitchen as well as ensure all health & safety regulations as mandated by law and Sandy Cove policy
- Clean up by putting away leftover food, sweeping/mopping floors, scrubbing and sanitizing work stations and washing utensils
- Stock delivered items, rotate stock and clean refrigerators and shelves as needed
- Complete any other reasonable task assigned

**Essential Skills and Experience**

- Ability to foresee needs and problem solve accordingly
- Flexible and has ability to adjust to guest needs
- Effective communication skills
- Strong organizational skills
- Creative
- Ability to work under pressure and produce accurate results

**Nonessential skills and experience:**

- Experience working in Christian camps or conference centers
- Knowledge of safe food handling procedures
- Prior food service experience (preferred)
